WHEREAS, the Planning Board of Borough of New Milford, County of Bergen, State of New Jersey, adopted its current Master Plan pursuant to <u>N.J.S.A</u>. 40:55D-28 on May 24, 2004 as subsequently updated in the reexamination reports dated June 7, 2010 and April 29, 2014; and

WHEREAS, the Master Plan includes a Housing Element pursuant to <u>N.J.S.A</u>. 40:55D-28b (3); and

WHEREAS, <u>N.J.S.A. 52:27D-304.1</u> requires the preparation of a Housing Element and Fair Share Plan to address the total Fourth Round fair share obligation of The Borough of New Milford and the adoption of the Housing Element Fair Share Plan by the Planning Board and endorsement by the Governing Body; and

WHEREAS, upon notice duly provided pursuant to <u>N.J.S.A.</u> 40:55D-13, the Planning Board of the Borough of New Milford held a public hearing on May 20, 2025; and

WHEREAS, the Planning Board has determined that the Housing Element and Fair Share Plan prepared by the Borough Planner, Paul Grygiel, P.P., of Phillips Preiss Grygiel Leheny Hughes, LLC, dated May 2025, is consistent with the goals and objectives of the Borough of New Milford's Master Plan and that adoption and implementation of the Housing Element and Fair Share Plan are in the public interest and protect public health and safety and promote the general welfare.

NOW THEREFORE BE IT RESOLVED by the Planning Board of The Borough of New Milford, County of Bergen State of New Jersey, that the Planning Board hereby adopts the May 2025 Housing Element and Fair Share Plan.
