## A Resolution Endorsing the Ridgefield Park Housing Element and Fair Share Plan.

**WHEREAS**, on March 20, 2024, Governor Murphy signed P.L. 2024, c.2 into law, which amended the 1985 New Jersey Fair Housing Act; and

WHEREAS, for ease in reference, this resolution shall refer to the Fair Housing Act as amended as "FHA II"; and

WHEREAS, FHA II established a procedure by which municipalities can secure approval of a Housing Element and Fair Share Plan ("HEFSP") and secure immunity while developing and seeking approval of a Plan; and

WHEREAS, that procedure contemplated that municipalities would adopt a resolution by January 31, 2025 committing to a fair share number and filing a declaratory relief action within 48 hours from adoption of the resolution and then filing a HEFSP by June 30, 2025 with the Affordable Housing Dispute Resolution Program (the "Program") within 48 hours of adoption of the Plan; and

WHEREAS, the Village asked its planner, Kenneth Ochab, PP/AICP, of Kenneth Ochab Associates to prepare a HEFSP to address the Village's affordable housing obligations under FHA II; and

WHEREAS, Mr. Ochab, prepared an HEFSP and the Ridgefield Park Planning Board adopted the HEFSP, which is attached hereto as Exhibit A; and

WHEREAS, in accordance with the procedure established by FHA II, the Village's Affordable Housing Counsel filed the duly adopted HEFSP with the Program within 48 hours from adoption; and

**WHEREAS**, the Village now wishes to endorse the HEFSP adopted by the Ridgefield Park Planning Board and seek approval of the HEFSP by the Program and Court.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Commissioners of the Village of Ridgefield Park, County of Bergen, State of New Jersey, as follows:
