WHEREAS, the Planning Board of the Township of Mount Laurel, State of New Jersey, adopted its current Master Plan pursuant to N.J.S.A. 40:55D-28 on June 25, 2025; and

WHEREAS, the Master Plan includes a Housing Element pursuant to N.J.S.A. 40:55D-28b(3); and

WHEREAS, N.J.A.C. 5:97-2.1(a) requires the adoption of the Housing Element by the Planning Board and endorsement by the Governing Body; and

WHEREAS, N.J.A.C. 5:97-3.1(a) requires the preparation of a Fair Share Plan to address the total 1987-2018 fair share obligation of the Township of Mount Laurel; and

WHEREAS, N.J.A.C. 5:97-3.1(b) requires the adoption of the Fair Share Plan by the Planning Board and endorsement by the Governing Body; and

WHEREAS, upon notice duly provided pursuant to <u>N.J.S.A</u>. 40:55D-13, the Planning Board of the Township of Mount Laurel held a public hearing(s) on the Housing Element and Fair Share Plan on June 25, 2025; and

WHEREAS, the Planning Board has determined that the Housing Element and Fair Share Plan are consistent with the goals and objectives of the Township of Mount Laurel's Housing Element and Fair Share Plan dated June 9, 2022 and on June 13, 2022 endorsed by the Township Council, and that adoption and implementation of the updated Housing Element and Fair Share Plan are in the public interest and protect public health and safety and promote the general welfare; and

WHEREAS, a public hearing was held before the Planning Board virtually via Zoom platform on June 25, 2025 with regard to this matter; and

WHEREAS, the Board has heard testimony and comments from the Township's Professionals, witnesses, and consultants, and with the public having had an opportunity to be heard.

NOW THEREFORE BE IT RESOLVED by the Planning Board of the Township of Mount Laurel, Burlington County, State of New Jersey, that the Planning Board hereby adopts the June 25, 2025, Housing Element and Fair Share Plan and refers this matter to the Governing Body for endorsement.
