**RESOLUTION OF THE TOWNSHIP OF WATERFORD APPOINTING A MUNICIPAL
HOUSING LIAISON PURSUANT TO THE FAIR SHARE HOUSING ACT**

WHEREAS, pursuant to P.L. 2024, c.2, the Township of Waterford is required to appoint a Municipal Housing Liaison for the oversight of administration of the Township's Affordable Housing Program to enforce the requirements of the Act; and

WHEREAS, the Township of Waterford has amended Chapter 79 of the Township Code captioned "Affordable Housing" to provide for the appointment of a Municipal Housing Liaison to administer the Township of Waterford's Affordable Housing Program.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of Waterford, County of Camden, and State of New Jersey that it thereby amends Chapter 79 of the Code of the Township of Waterford to appoint Michael Ward as the Municipal Housing Liaison for the Township of Waterford for the administration of the Affordable Housing Program and authorizes a salary of \$5,000.00 annually for an employee serving in this position.

BE IT FURTHER RESOLVED this Resolution shall take effect immediately upon adoption.
