**RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF LOGAN
ENDORING THE TOWNSHIP'S AMENDED HOUSING ELEMENT AND FAIR
SHARE PLAN FOR THE FOURTH ROUND: 2025-2035**

WHEREAS, the Logan Township Planning Board adopted the Township's Housing Element and Fair Share Plan for the Fourth Round (2025-2035) on June 12, 2025, via Resolution No. 14-2025; and

WHEREAS, the governing body adopted the Township's Housing Element and Fair Share Plan for the Fourth Round (2025-2035) on June 17, 2025, via Resolution No. 169-2025; and

WHEREAS, on March 12, 2026, the Logan Township Planning Board adopted an Amended Housing Element and Fair Share Plan for the Fourth Round: 2025-2035 dated March 1, 2026, via Resolution No. 07-2026; and

WHEREAS, the Township of Logan remains committed to comply with its constitutional Mount Laurel obligations by voluntarily providing its "Fair Share" of affordable housing and pursuing approval of its Amended Housing Element and Fair Share Plan for the Fourth Round: 2025-2035 dated March 1, 2026, from the Program and the Court.

WHEREAS, the governing body seeks to endorse the Amended Housing Element and Fair Share Plan for the Fourth Round: 2025-2035 dated March 1, 2026; and

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Township Council of the Township of Logan, Gloucester County, State of New Jersey, hereby endorses the Amended Housing Element and Fair Share Plan for the Fourth Round: 2025-2035 dated March 1, 2026, as adopted by the Logan Township Planning Board on March 12, 2026.


BE IT FURTHER RESOLVED that the Council of the Township of Logan, pursuant to the provisions of N.J.S.A. 52:27D-301 et seq. hereby authorizes and directs its professionals to immediately file the adopted and endorsed Amended Housing Element and Fair Share Plan for the Fourth Round: 2025-2035 dated March 1, 2026, and all other relevant documents with the Dispute Resolution Program.

BE IT FURTHER RESOLVED that the Council of the Township of Logan, pursuant to the provisions of N.J.S.A. 52:27D-302, et seq. and the Fair Housing Act, requests that the Department of Community Affairs accept and file the Amended Housing Element and Fair Share Plan for the Fourth Round: 2025-2035 dated March 1, 2026, as adopted by the Logan Township Planning Board on March 12, 2026.


