RESOLUTION ENDORSING THE HOUSING ELEMENT AND FAIR SHARE PLAN ADOPTED BY THE PLANNING BOARD OF THE TOWN OF SECAUCUS

WHEREAS, the Fair Housing Act of 1985 was amended on March 20, 2024 and established a procedure by which municipalities can secure approval of a Housing Element and Fair Share Plan; and

WHEREAS, the procedure contemplated that municipalities would adopt a resolution by January 31, 2025 with respect to their present and prospective affordable housing obligations; and

WHEREAS, the Mayor and Council of the Town of Secaucus ("Town") adopted a binding resolution on January 28, 2025, with respect to its present and prospective affordable housing obligations; and

WHEREAS, the Town filed a lawsuit entitled <u>In the Matter of the Application of the</u> <u>Town of Secaucus, New Jersey</u> in the Superior Court of New Jersey, Law Division, Hudson County, under Docket No. HUD-L-000377-25, on January 30, 2025, within 48 hours of the adoption of the January 28, 2025 resolution with respect to its present and prospective affordable housing obligations; and

WHEREAS, a Housing Element and Fair Share Plan was drafted to address the Town's affordable housing obligations under the Fair Housing Act, as amended; and

WHEREAS, the Planning Board adopted the Housing Element and Fair Share Plan on June 17, 2025; and

WHEREAS, a true copy of the Resolution of the Planning Board adopting the Housing Element and Fair Share Plan is attached hereto as Exhibit A; and

WHEREAS, in accordance with the procedure established under the Fair Housing Act, the Housing Element and Fair Share Plan was filed within 48 hours of its adoption by the Planning Board; and

WHEREAS, the Town now desires to endorse the Housing Element and Fair Share Plan and to seek its approval by the Affordable Housing Dispute Resolution Program and the Superior Court.

NOW THEREFORE BE IT RESOLVED, that the Mayor and Council of the Town of Secaucus hereby endorse the Housing Element and Fair Share Plan, as adopted by the Town of Secaucus Planning Board, and directs its affordable housing counsel to file this resolution and to seek a compliance certification from the Affordable Housing Dispute Resolution Program and/or the Superior Court, formally approving the Plan.

WHEREAS, upon notice duly provided pursuant to N.J.S.A. 40:55D-13, the Planning Board of Town of Secaucus held a public hearing on the Housing Element and Fair Share Plan on June 17, 2025; and
