A RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN AND STATE OF NEW JERSEY ACCEPTING THE NEW JERSEY DEPARTMENT OF COMMUNITY AFFAIRS AFFORDABLE HOUSING OBLIGATIONS FOR THE FOURTH ROUND

WHEREAS, the New Jersey Legislature passed into law amendments to the Affordable Housing Act N.J.S.A. 52:27D-304.1 et seq.; and

WHEREAS, pursuant thereto the New Jersey Department of Community

Affairs ("DCA") was to adopt the fourth round affordable housing fair share

obligations for all municipalities within the State of New Jersey in October of

2024; and

WHEREAS, the regulations require that municipalities must decide whether to accept its affordable housing fair share obligations promulgated by DCA by resolution adopted on or before January 31, 2025 or risk losing its immunity from exclusionary zoning litigation; and

WHEREAS, the Township of Barnegat has received its DCA fair share housing obligation for the fourth round which indicates the Township has a present need of 38 affordable housing units and a prospective need of 71 affordable housing units; and

WHEREAS, the Township desirous to accept the DCAs fourth round fair share methodology numbers.

NOW THEREFORE BE IT RESOLVED on this 1st day of January, 2025, by the Mayor and Township Committee of the Township of Barnegat, County of Ocean, and State of New Jersey as follows:
