RESOLUTION NO. 2025 - 254

RESOLUTION OF THE TOWNSHIP OF STAFFORD, COUNTY OF OCEAN, STATE OF NEW JERSEY ENDORSING THE PLANNING BOARD'S ADOPTION OF THE FOURTH ROUND AFFORDABLE HOUSING ELEMENT AND FAIR SHARE PLAN

WHEREAS, on March 20, 2024, Governor Murphy signed into law P.L. 2024C2 which amended the affordable housing laws in the State of New Jersey and mandated that the Fourth Round Affordable Housing Obligation be determined by the New Jersey Department of Community Affairs ("DCA"); and

WHEREAS, DCA issued its nonbinding affordable housing obligations for all municipalities in the State on October 18, 2024; and

WHEREAS, pursuant the law, municipalities had until January 31, 2025 to either accept DCA's calculations or file declaratory judgment actions in the Superior Court of New Jersey before the newly established Affordable Housing Dispute Resolution Program ("the Program"); and

WHEREAS, DCAs calculation for Stafford Township set forth that the Township's present need of 38 affordable housing units and a prospective need of 208 affordable housing units; and

WHEREAS, the Township filed a Declaratory Judgment Action to the Superior Court of New Jersey, Law Division, Civil Part, Ocean County, Docket No. OCN-L-96-25, challenging the prospective need calculations of the DCA; and

WHEREAS, the Township reached a settlement agreement with Fair Share Housing Center ("FSHC") to reduce the prospective need to 175 units and same was memorialized pursuant to Township Resolution 2025-120 which was adopted by the Township Council on March 27, 2025; and

WHEREAS, pursuant to the affordable housing law municipal planning boards are required to adopt a Fourth Round Housing Element and Fair Share Plan on or before June 30, 2025; and

WHEREAS, as part of the Housing Element and Fair Share Plan is the Township's vacant land adjustment ("VLA") and realistic development potential analysis ("RDP"); and

WHEREAS, the Township's Planner and Affordable Housing Planner calculated an RDP of 44 and reduced that RDP to 17 for the Fourth-Round obligation; and

WHEREAS, on June 25, 2025, the Stafford Township Planning Board adopted a Resolution adopting Stafford Township Affordable Housing Element and Fair Share Plan for the Fourth Round prepared by CME Associates dated June 2, 2025; and

WHEREAS, it is now the intent of the Mayor and Township Council of the Township of Stafford to endorse the action of the Township Planning Board in adopting the Affordable Housing Element and Fair Share Plan.

NOW THEREFORE BE IT RESOLVED this **15**th day of **July, 2025**, by the Mayor and Township Council of the Township of Stafford, County of Ocean, and State of New Jersey as follows:

- 1. The Township hereby endorses the action of the Stafford Township Planning Board adopting a Resolution which adopted the Stafford Township Affordable Housing Element and Fair Share Plan for the Fourth Round dated June 2, 2025 prepared by CME Associates.
